- Recent passport-size photos (less than 6 months old)

3. Payment

- o If choosing offline payment, visit the office to complete the registration
- Payment can be made via cash or credit card.

4. Access Arrangements (if applicable)

- Submit a detailed medical report (not older than 2 years)
- o Include an Access Arrangement application form
- Must be re-applied for each exam session





Study Duration Guidelines:

- IGCSE: 2-year course; exams usually in Year 10 or later
- IAL (AS/A Level):
 - AS Level: End of Year 11 or later
 - o A2 Level: End of Year 12 or later
